The terms & conditions for this offer are as follow, failing which the quotation shall be rejected out rightly.

Terms and Conditions

1. The rate should be inclusive of GST and all taxes, duties, labor charges and transportation, loading unloading, watch and ward etc. at Concerned Puna Gam SUMAN School.
2. Work shall be carried out as per instruction of engineer in charge and as per site requirement.
3. Payment shall be done accordingly to actual work carried out at site.
4. 90% amount of will be released after completion of work and submission of Invoice.
5. Remaining 10% shall be released after satisfactory commissioning of the entire work.
6. Time limit for the work should be 15 days after 10 days of work order date. Failing which penalty @ 0.2% of order value of unexecuted portion per day of delay subject to maximum 10% of unexecuted portion order value shall be charged and shall be deducted from the bill.
7. Defect liability period shall be one year after completion of the work.
8. The successful Contractor shall be required to deposit an amount equal to 2% of the total order value as Security Deposit in Municipal Treasury in Cash/ by Demand Draft within 15 (Fifteen) days of order failing which penalty @ 0.065% of the Security Amount per day of delay shall be charged.
9. The successful contractor shall also be required to enter into contract agreement along with undertaking and local surety on Gujarat Stamp Paper purchased from Surat worth Rs.900.00 (i.e. 300.00 + 300.00 + 300.00 for each) (to be brought from Surat by the contractor) on getting the order. However, the stamp duty at prevailing rate shall be applicable if revised by Government.
10. Corporation will not issue any 'C' or 'D' form.
11. The offer shall remain valid up to 120 days from the date of receipt of the quotation.
12. Corporation reserves the right to accept or reject any or all the quotations without assigning any reason thereof.
13. Contractor has to strictly follow the make mention above and provide necessary documents to prove for genuineness of material up to the satisfaction of engineer in charge. The payment will be made only after approval of genuineness.
